Strengthening



1. Strengthening

We provide advisory services to resolve specific legal and tax cases, and offer ongoing support through group training sessions.

TAX

We offer group training sessions for organizations seeking to obtain authorized donee status in Mexico:

1. Guidance on maintaining authorized donee status
2. Answering questions about compliance with the obligations of authorized donees

CIVIL AND CORPORATE

We provide guidance in preparing specific documents related to civil and governance matters.

1. Legal incorporation and amendment of the civil association's bylaws
2. Contracts and documents suited to each type of transaction
3. Privacy notices and personal data processing policies
4. Meeting minutes and minute books
5. Good governance practices for the sector



LABORAL

We support compliance with employer obligations, with an emphasis on the implications of the different hiring regimes for organizations:

1. Labor and hiring policies
2. Internal workplace regulations
3. Policies derived from official standards (psychosocial risk factors in the workplace and telework)
4. Hiring and salary adjustments

ANTI-MONEY LAUNDERING (AML)

We provide guidance for compliance with AML obligations:

1. Identifying donations as a vulnerable activity, and their accumulation
2. Registering on the AML portal and accepting the role of AML compliance officer
3. Compiling donor files
4. Responding to requests and inspection visits by the SAT (Mexican Tax Administration Service) or the Financial Reporting Unit (UIF)

2. MANAGEMENT

We provide advisory services in administrative, accounting, and tax matters in order to optimize the use of resources, minimize risks, reduce costs, and develop sustainability strategies.

ACCOUNTING

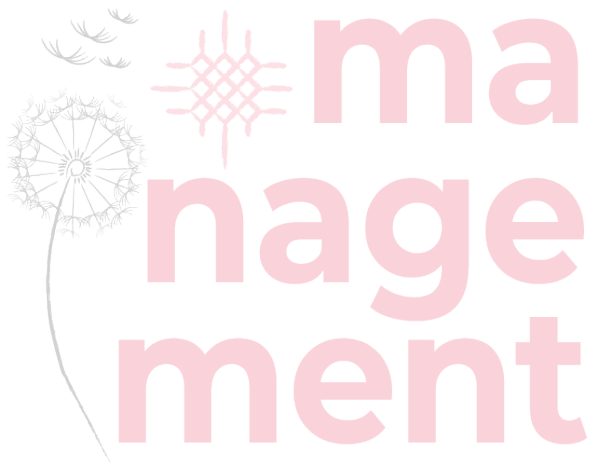
We advise on compliance with tax obligations:

1. Registration of the legal entity with the Federal Taxpayers Registry (RFC)
2. Issuance of digital tax receipts (CFDI)
3. Electronic accounting
4. Backup of income and expense records
5. Interpretation of financial statements
6. Transparency information return
7. Annual Income Tax (ISR) return

SOCIAL SECURITY

We advise on compliance with social security obligations:

1. Employer registration with the Mexican Social Security Institute (IMSS)
2. Cost projections for different hiring schemes
3. Calculation of severance payments or settlements



DISBURSEMENTS

We advise on procedures related to international transactions:

1. Double taxation treaties for transactions involving payments to foreign residents
2. Tax regime for international workers and consultants
3. Tax obligations of representative offices

ACCOUNTING FOR AUTHORIZED DONEES

We provide specialized accounting and tax advisory services for authorized donees.

1. Bookkeeping and preparation of financial statements
2. Filing of monthly and annual returns, and the transparency information return
3. Filing of anti-money laundering (AML) obligations
4. Submission of electronic accounting records
5. Response to requests from the relevant authorities
6. Payroll administration
7. Local taxes (payroll tax)
